A) – PRE-REGISTRATION

1 DATES

THURSDAY, FEBRUARY 23, 2023

At 7 PM -Opening of pre-registrations.

TUESDAY, FEBRUARY 28, 2023

At 9 AM -Closure of pre-registrations.

TUESDAY, MARCH 07, 2023

Application deadline for full payment of entry fees. The date of the postmark or the date of registration of the transfer being authentic.

TUESDAY 14 MARCH 2023

Sending, by the MCLivradois, of a nominative email of communication of your **team name** previously entered during your pre-registration asking you to verify its accuracy and to communicate to us, by return email, a possible change before **March 18, 2023**.

2. **PROCEDURE** (Rev. 1)

- On the dates and times mentioned above, access through our site www.randauvergne.com, at a blank sheet of pre-registration must be duly completed by the interested.
- Once the registration is validated, a terminal message indicates the confirmation dates for all pre-registrations. On these dates, a personal e-mail is sent to all pre-registrants, confirming that all valid pre-registrations have been taken into account. A personal registration number will be sent along with the bank details of the motorcycle club, allowing you to pay the entry fees before the deadline indicated in §1. The registration number will be kept until the day of the administrative control. (Rev. 1)

IMPORTANT : ***The pre-registration will be fully effective only after receipt of the full payment of the amount referred to in paragraph C).***

FRIDAY, JUNE 09, 2023.

- All race numbers communicated by nominative email as well as your schedules for the various checks of **Friday, June 23, 2022.**

C) - AMOUNT ENTRY FEES - REFUND:

1 - Amount and MODE of regulation

For all the participants, the entry fees are fixed at **€295**, with the exception of participants on **50cc** motorcycles with an **NJ3C** or **NCO** or **LJB2** licenses are set at **€150** and will be addressed:

- For all pre-registered



- **Only** by bank transfer of which you will find the details of the Moto Club associated with your validation of pre-registration.



IMPORTANT : ***Obligation to issue a transfer per driver engaged by mentioning imperatively during its transmission:***

- Its pre-registration number.

2 - DEFECTION, REFUND:

- Defection:

Admissible with the organization **by email until June 09, 2023** inclusive, specifying the bank details of the withdrawal.

- Reimbursement of commitment fees:

Will  **only** be done:

- By bank transfer.



IMPORTANT : *The admissibility of the deflection time spent, refund won't be taken into account by the host club regardless of the reason.*

(D) – ADDITIONAL IMPORTANT NOTIFICATIONS:

- The Organizing Committee reserves the right to refuse the entry of a competitor without having to explain why (article 74 of the C.S.I. *(International Sporting Code)*).
 - *No possible commitment verbally, by telephone, on paper or by e-mail.*
 - *In any case, a driver may exchange its commitment with another pilot.*

- *For residents off of the French territory and not licensed to the F.F.M:*
 - *1) - National or international foreign license holders will be required to present with the latter, during the administrative checks of the test, a **written authorization to leave from their federation**. In the absence of this document they must, if they wish to participate in the event, subscribe to a license "event day" (Cf. §-IV - **section 7 - page 6/13** of the particular regulation of the event).*
 - *2) - No national or international foreign license holders will be required to subscribe to a license "event day" (Cf. §-IV - **section 7 - page 6/13** of the particular regulation of the event).*
